### NRA Shooting For the Future Program

Sinclair International has been collecting money for the NRA for several years. If you are not aware of the program, it's really quite painless. You simply tell us to round-up your order amount to the next highest dollar and we forward that entire amount to the NRA Foundation on behalf of the Sinclair customers. No money is held for administering this program, 100% of the funds go directly to the NRA. This is a great program because a few cents on each order add up to a large amount for the NRA.

### Method Of Payment

We accept MasterCard, Visa, Discover, American Express, Cashiers Checks, Money Orders, and personal checks. Personal checks will be held for clearing prior to the shipment of your order, except for established customers.

### Domestic Shipping

We ship UPS Ground or US Postal Service within the continental United States (unless requested otherwise) for a flat fee of \$11.95. Next Day, Second Day, and Three Day UPS services are available for an additional charge. Please provide street addresses, since UPS cannot deliver to Post Office Boxes. Orders shipped to Alaska or Hawaii will be sent via Priority Mail (unless UPS is requested) and are subject to actual shipping charges. Orders under 12 ounces that can be shipped via the US Postal Service may qualify for a reduced shipping rate.

### Hazardous Shipping

There will be a Hazardous charge of \$25.00 added to all UPS Ground orders that include Powder and/or Primers. All Hazardous products must ship by UPS and deliver to an address within the continental United States. No primers, powder, aerosols, or rimfire ammunition may be sent by US Postal Service, domestically or overseas.

### International Shipping

All orders shipped out of the United States must be pre-paid in U.S. funds or charged to a credit card. International Money Orders in U.S. funds are also acceptable. Hazardous or ORM-D products such as aerosols, most cleaning solutions, and oils cannot be shipped overseas. Rifle parts (actions, triggers, trigger guard assemblies, stocks, firing pins, barrels, buttplates, etc.) brass, bullets, primers, powder and some optics cannot be shipped to non-U.S. citizens. Cleaning rods longer than 36", hard gun cases, flag stands, and other long objects cannot be shipped out of the United States via Postal Service (except Canada) due to postal regulations. We normally ship most orders via UPS or the Postal Service. Please indicate shipping preference when ordering. If you would like a shipping quote, please ask for one.

### Back Orders

We try to avoid back orders from occurring by having plenty of inventory on hand at all times, but occasionally they do happen. If we do not expect to have an item available within 30 days, we will not back order the item unless specifically requested by the customer. Back order shipments are not charged a freight charge within the United States. We do not back order components such as powder, bullets, brass, and primers due to fluctuating availability from the manufacturers. We will be glad to put your name on our contact list for in-stock status.

### Returns

If you need to return an item, use the return form on the back of your original packing slip. If you are experiencing difficulty in using an item, please call, we may be able to alleviate the problem by phone. When returning an item please provide the following: 1) A copy of the packing slip, 2) The reason you are returning and 3) Whether you wish to exchange or refund. If the return is due to an error on our part, we will reimburse you for UPS Ground or 1st Class mail charges. Returns made by customer through C.O.D. to collect refund will be refused.
